AND WHEREAS the Province and Federal Government disproportionally receives added revenue through continued economic development;

AND WHEREAS Municipal governments have limited options for funding long term infrastructure investments, through property taxes, utility rates or user fees;

THEREFORE BE IT RESOLVED THAT the AMM lobby the Provincial and Federal Governments for increased grant funding (proportion and total investment) in Water & Wastewater infrastructure to continue to facilitate economic growth within the Province of Manitoba.
